Moja družina se lahko pohvali z dolgo tradicijo v kinologiji. Moj dedek je več kot 70 let delal z lovskimi in športnimi psi.

Leta 1989 sem začel svojo pot v delovnih preizkušnjah (SchH) z mojo nemško ovčarko. Z njo sem leta 1991 začel lastno vzrejo in leta 1993 je bila registrirana moja psarna Zlatolična.

Vsi moji psi imajo opravljene izpite SchH, IPO in IGP, dve psici pa imata tudi izpit FH. V zadnjih 38 letih sem vzredil več kot 40 prvakov po vsem svetu. Moji psi so dosegali naslove, kot so mednarodni prvak, svetovni prvak in evropski prvak.

Dolga leta sem bil član vzrejne komisije za bokserje in nemške ovčarje, predsednik vzrejne komisije za rotvajlerje in dobermane ter podpredsednik Kluba ljubiteljev nemških bokserjev Slovenije. Trenutno sem član delovne komisije Boxer kluba Srbije.

Od leta 1988 imam licenco za markerja in inštruktorja IGP. Večkrat sem sodeloval kot marker na Körungu za nemške ovčarje in na ZTP za bokserje, rotvajlerje in dobermane.

Moja sodniška pot se je začela leta 1995 in danes sem mednarodni sodnik za vse pasme (All- Round & BIS) ter sodnik za bokserje, nemške ovčarje, dobermane in rotvajlerje. Prav tako sem mednarodni FCI in ATIBOX sodnik za IGP, FH in poslušnost.

Sodil sem v številnih državah, med drugim v Latviji, Indoneziji, na Filipinih, v Indiji, Avstriji, na Madžarskem, v Sloveniji, Srbiji, na Hrvaškem, v Bosni, Bolgariji, na Danskem, v Rusiji, Črni gori, na Češkem, v Italiji, Ukrajini, San Marinu, na Poljskem, v Litvi, na Nizozemskem, v Severni Makedoniji in Grčiji.

Sodil sem na številnih specialnih razstavah za bokserje, klubskih razstavah in letnih razstavah po vsem svetu.

V veliko čast in veselje mi bo soditi na vaši razstavi.

DUŠAN TRAVNIKAR

My family has a long history in the dog world. My grandfather worked with hunting and sporting dogs for more than 70 years.

In 1989 I started my journey in working trials (SchH) with my female German Shepherd. With this female I began my own breeding in 1991 and in 1993 my kennel name Zlatolična was established.

All my dogs have SchH, IPO, and IGP exams and two females also have FH exams. Over the past 38 years I have bred more than 40 champions all over the world. My dogs have earned titles such as International Champion, World Champion and European Champion.

For many years I was a member of the breeding commission for Boxers and German Shepherds, president of the Rottweiler and Dobermann breeding commission, and vice president of the Boxer Club Slovenia. Currently I am a member of the working commission of the Boxer Club Serbia.

Since 1988 I have held a working license as a helper and IGP instructor. I have often worked as a helper in Körung for German Shepherds and ZTP for Boxers, Rottweilers and Dobermanns.

My judging career started in 1995 and today I am an All-Round & BIS international judge, as well as a specialist judge for Boxers, German Shepherds, Dobermanns and Rottweilers. I am also an international FCI and ATIBOX judge for IGP, FH and Obedience.

I have judged in many countries, including Latvia, Indonesia, the Philippines, India, Austria, Hungary, Slovenia, Serbia, Croatia, Bosnia, Bulgaria, Denmark, Russia, Montenegro, the Czech Republic, Italy, Ukraine, San Marino, Poland, Lithuania, the Netherlands, North Macedonia and Greece.

I have judged many Boxer specialty shows, club shows and annual winner shows around the world.

It would be my pleasure to judge at your show.

RAZSTAVNI RED / SHOW RULES

POMEMBNA OBVESTILA

Razstavljajo se lahko le psi z rodovnikom, ki ga priznava FCI. Razstavljavci morajo imeti na razstavi s seboj originalni rodovnik psa. Razstave se ne smejo udeležiti bolni psi. Med razstavo morajo biti vsi psi na vrvici, ostri psi pa morajo nositi nagobčnik. Lastnik psa je odgovoren za škodo, ki jo povzroči njegov pes. Razstavljavec mora priti pravočasno v svoj ocenjevalni krog, po vrstnem redu, ki je določen v katalogu. S prijavo na razstavo razstavljavci priznavajo pravila Kinološke zveze Slovenije o prireditvah. Organizator si pridržuje pravico zamenjave sodnikov. Obveza plačila prijavnine obstoji ne glede na to, ali je bil pes dejansko pripeljan na razstavo ali ne. Pritožbe razstavljavcev se obravnavajo samo v času razstave, po predhodnem plačilu kotizacije v višini 100€. V primeru, da je pritožba utemeljena, se razstavljavcu kotizacija povrne v celotnem znesku. Pritožbo lahko podajo samo razstavljavci, ki so navedeni v katalogu.

SKLEPI MEDNARODNE KINOLOŠKE ZVEZE (FCI) IN KINOLOŠKE ZVEZE SLOVENIJE (KZS)

1. Prepovedana je uporaba vseh kemičnih sredstev pri urejevanju psov.
2. Na razstavah je prepovedan »double handling«, postavljanje psa na psa v krogu.
3. Vsaka agresija se takoj kaznuje z diskvalifikacijo psa.
4. Na razstavah je prepovedano razstavljanje kupiranih psov vseh pasem, skotenih po 1.1.2015, razen za pse s kupiranimi repi ob predložitvi veterinarskega potrdila. Razstavljavec je dolžan veterinarsko potrdilo predložiti ob prijavi na razstavo in sodniku fizično v razstavnem krogu.
5. Za prijavo na razstavo se upošteva sklep 5.2-69/2022, ki omogoča prijavo psov, ki so že Slovenski prvaki v lepoti prijavo tudi v druge razrede. Sklep velja od 1.7.2022 dalje.

VETERINARSKA DOLOČILA

Psi morajo biti veljavno cepljeni proti steklini z inaktivirano ali rekombinantno vakcino. Veljavnost zaščite proti steklini nastopi najmanj 21 dni po primarnem cepljenju in se nadaljuje, glede na nacionalno shemo cepljenja, kot je navedel pooblaščen veterinar v izhodiščni državi v potnem listu za psa.

FCI OBVESTILO – V DOBROBIT PSOV

Razstavjalci so odgovorni za dobrobit psov in njihovo zdravje na razstavi. Prepovedano je pse izpostavljati situacijam, ki so lahko nevarne za njihovo zdravje in dobrobit, kot npr. puščanje psa v avtomobilu v vročem ali premrzlem vremenu oziroma kruto ravnanje psov. Če razstavljavec krši ta pravila, se ga izključi iz te in vseh prihodnjih razstav.

OBVESTILO O VARSTVU OSEBNIH PODATKOV

Razstavljavec soglašaja, da organizator obdeluje in uporablja zbrane osebne podatke za namene v zvezi z razstavami in da te podatke ter slikovni material o razstavi javno objavi.

POMEMBNA OPOZORILA

Na razstavi morajo biti vsi psi na vrvici, ostri psi pa morajo nositi nagobčnik. Razstavljavci so odgovorni za morebitno škodo, ki bi jo povzročili njihovi psi na stvareh ali tretjim osebam. Organizator ne prevzema nobene odgovornosti.

PRITOŽBE

Razstavjalci se lahko pritožijo samo v času razstave, v pisni obliki. Dovoljena je pritožba glede organizacije in napake v postopku ocenjevanja. Odločitev sodnika glede ocene, kandidatur in uvrstitve je dokončna. Pritožba je sprejemljiva le v pisni obliki, ob vložitvi pritožbe in ob plačilu kavicije v znesku 100 EUR. Če je pritožba rešena v prid pritožnika, se mu kavicija vrne.

IMPORTANT NOTICE

Only the dogs with the FCI recognized pedigree may be shown. The original pedigree is to be available at the show. Sick dogs cannot take part in the show. Exhibitors are responsible for any damage caused by their dogs. The organizer refuses all responsibility. All dogs should be kept on a leash at all times and muzzled if aggressive. The exhibitor is liable for any damages caused by his/her dog(s) at the show. The exhibitor is liable for the presentation of his/her dog(s) by the catalog numbers in the ring in due time. By signing the registration form, exhibitors accept to conform to the Slovenian Kennel Club Bylaws on Exhibiting. The organizer reserves the right to substitute the judges. The registration fee is to be settled regardless of whether the registered dog is shown or not. Exhibitors' complaints will be dealt with at the show only after paid deposit of 100€. If the complaint is justified, the deposit will be refunded in full amount. A complaint can only be given by the exhibitor, who is registered for the show.

DECISION OF THE FÉDÉRATIION CYNOLOGIQUE INTERNATIONALE (FCI) AND THE CYNOLOGICAL ASSOCIATION SLOVENIA (CAS)

1. Use of chemical substances in dog grooming is prohibited.
2. Double handling and placing dog against dog is prohibited.
3. Any aggression is immediately penalized by the disqualification of the dog.
4. Cropped or docked dogs, born after 1.1.2015 cannot be shown. Exceptions are docked dogs for medical reasons with veterinarian certificate enclosed with the entry form and presented to the judge at the show.
5. Regarding Article 5.2-69/2022 UO KZS, dogs who obtain Slovenian Beauty Championship title can enter in any class. It is not obligatory for them to enter into Champion class. Valid from 1.7.2022

VETERINARY CONDITIONS

All dogs must be validly vaccinated against rabies with an inactivated or recombinant vaccine. The validity of the vaccine and protection against rabies begins at least 21 days after the primary vaccination and continues, according to the national vaccination schedule, as indicated by the veterinarian of the country of origin in the dog's passport.

FCI ANNOUNCEMENT – DOG WELFARE AT THE DOG SHOWS

The exhibitors are responsible for the welfare of the dogs at the dog show. It is forbidden to expose a dog to a situation that can be dangerous for its health and welfare, such as for example leaving in the car in excessively hot or cold weather and/or treating in a cruel manner. Violation of this ruling will result in exclusion from the ongoing and further dog shows.

PERSONAL DATA PROTECTION NOTICE

The exhibitor agrees that the show organizer processes and uses the collected personal data for the dog shows purposes and allows publishing of these data as well as of the show photo material.

COMPLAINTS

Exhibitors can complain only at the show. The complaints must be in a written form, and can be made only about the organisation of the show and about procedure followed to give the qualifications. The deposit of 100 EUR must be paid as surety. In case of the positive complaint, the money is returned to the complainer.

IMPORTANT NOTICES

All dogs should be kept on leash at all times and muzzled if aggressive. Exhibitors are responsible for any damage caused by their dogs. The organizer refuses all responsibility.

Nazivi in ocene

Sodnik lahko podeli v vseh razredih, razen razredu mladičev in najmlajših, naslednje ocene: odlično, prav dobro, dobro, zadostno, diskvalificiran / neocenjen.

Odlično ocenjene pse v vseh razredih se razvrsti po posameznih mestih (1. do 4. mesto v razredu).

Sodnik lahko podeli v razredih mladiči in najmlajši naslednje opisne ocene: zelo perspektiven, perspektiven, manj perspektiven.

Odlično ocenjenim psom lahko sodnik v ocenjevalnem krogu podeli naslednje naslove:

- CAC, R CAC
- J CAC
- V CAC
- Mladi letni in mladi klubski prvak
- Letni in klubski prvak
- Veteranski letni in veteranski klubski prvak
- V BOB, J BOB, BOB in BOS

Psi bele barve se razstavljajo izven konkurence. Podeli se jim samo opis, brez ocene. Med njimi se izbere najlepšega belega bokserja. Ne morejo kandidirati za noben drugi naziv.

Qualifications and Titles

The judge may give in all classes except minor puppy and puppy following qualifications: Excellent, Very Good, Good, Sufficient, Disqualified / Cannot be judged.

The four best dogs in each class are placed provided that they have been awarded the qualification of Excellent (1st place – 4th place).

The judge may give in minor puppy and puppy classes the following qualifications:

Very promising, Promising, Not promising.

The judge may give to dogs which have been awarded Excellent:

- CAC, R CAC
- J CAC
- V CAC
- Junior Year and Junior Club Winner
- Year and Club Winner
- Veteran Year and Veteran Club Winner
- V BOB, J BOB , BOB in BOS

White dogs are exhibited out of competition. They are only given a description without a rating. The best white boxer should be chosen from among them. They cannot compete for any other title.

POJASNILA

MLADI LETNI PRVAK: Za naziv kandidirajo psi iz razreda mlajših in razreda mladih, ki prejmejo oceno odlično 1. Podeljuje se ločeno po spolu in barvi.

LETNI PRVAK: Za naziv kandidirajo psi iz razreda delovnih, ki prejmejo oceno odlično 1 in CAC. Podeljuje se ločeno po spolu in barvi.

VETERANSKI LETNI PRVAK: Za naziv kandidirajo psi iz razreda veteranov, ki prejmejo oceno odlično 1. Podeljuje se ločeno po spolu in barvi.

MLADI KLUBSKI PRVAK: Za naziv kandidirajo psi, ki so prejeli naziv Mladi letni prvak. Podeljuje se ločeno po spolu.

KLUBSKI PRVAK: Za naziv kandidirajo psi, ki so prejeli CAC v razredu vmesnih, odprtih in prvakov ter letna prvaka. Podeljuje se ločeno po spolu.

VETERANSKI KLUBSKI PRVAK: Za naziv kandidirajo psi, ki so prejeli naziv Veteranski letni prvak. Podeljuje se ločeno po spolu. Veteranski klubski prvak in veteranska klubska prvakinja tekmujeta za naziv veteranski prvak pasme (V BOB).

CAC: Ta naziv lahko sodnik podeli prvouvrščenemu psu in psici z oceno odlično 1 v razredu vmesnih, odprtih, delovnih in prvakov.

R CAC: Ta naziv lahko sodnik podeli drugo uvrščenemu psu in psici z oceno odlično 2 v razredu vmesnih, odprtih, delovnih in prvakov. V primeru da sodnik ne podeli naziva CAC, ne sme podeliti naziva R CAC.

J CAC: Ta naziv lahko podeli sodnik prvouvrščenemu psu in psici v razredu mlajših ali razredu mladih z oceno odlično 1. Podeljuje se ločeno po spolu in barvi. Podeli ga psom, ki so prejeli naziv mladi letni prvak.

V CAC: Ta naslov lahko podeli sodnik prvouvrščenemu psu in psici v razredu veterani z oceno odlično I.

PRVAK PASME - BOB in PRVAK NASPROTNEGA SPOLA - BOS: Za naziv se potegujejo psi in psice, ki so prejeli nazive najlepši mladi pes (J BOB), klubska prvaka in najlepši veteran (V BOB). Sodnik naredi ožji izbor, in sicer izbere najboljšega psa in najboljšo psico. Potem izbere BOB in BOS.

PAR: tvorita ga pes in psica iste pasme, ki sta na dan razstave v lasti iste osebe in pozitivno ocenjena.

VZREJNA SKUPINA: Tvorijo jo najmanj trije psi istega vzreditelja. Vsi psi, ki tvorijo vzrejno skupino, morajo biti na razstavi pozitivno ocenjeni. Psi so lahko v lasti različnih oseb.

EXPLANATIONS

JUNIOR YEAR WINNER: Dogs running for the title from classes Younger and Young that received mark Excellent 1. It is awarded separately according to sex and colour.

CLUB WINNER: Dogs that received title CAC in Class Intermediate, Open, Champion and Year Winner. It is awarded separately according to sex.

VETERAN CLUB WINNER: Dogs that received title Veteran Year Winner running for the title. It is awarded separately according to sex. The dog and the bitch which received title Veteran Club Winner are competing for the V BOB title.

CAC: This title can be awarded by a judge to the first rank male and female with mark Excellent 1, in class Intermediate, Open, Working and Champion.

R CAC: This title can be awarded by a judge to the second rank male or female with mark Excellent 2 in class Intermediate, Open, Working and Champion. In case the judge does not award CAC, he cannot award R CAC.

J CAC: This title can be awarded by a judge to the first rank male and female in class Youth and Young with mark Excellent 1. It is awarded separately according to sex and colour. It is awarded to the males and females that were awarded with title Junior Year Winner.

V CAC: This title may be awarded by the judge to the first-placed male and female dog in the veteran class with mark Excellent I.

BOB and BOS: For this title are competing males and females that received J BOB, Club Winner and V BOB. Best male and best female compete for Best of Breed (BOB) and Best of Opposite Sex (BOS).

BRACE: Male and female of the same breed, owned by the same owner, with the positive grade on the show.

BREEDING GROUP: At least 3 dogs of the same breeder. All dogs in the group, with positive grade on the show.
